1. Purpose. The purpose of this notice is to establish the Drill Schedule for the Ben Moreell Battalion and TS Nicholas H. Anderson. This drill schedule is subject to change. Plans of the Day with final dates and times will be promulgated prior to each drill date.

2. Background. In accordance with reference (a), each unit in the NSCC / NLCC is required to complete a minimum of forty (40) drill periods per calendar year. Each weekend drill can be counted as one drill period for every 3 to 4 hours of training. Ben Moreell Battalion traditionally drills approximately 2 Saturdays each month.

4. Action. All Cadets and Staff are required to be present for all drills. Cadets MUST contact their Leading Petty Officer via the chain of command no less than 48 hours prior to a scheduled drill if they will not be in attendance. Staff must inform the Executive Officer of any drills for which they will not be in attendance. Failure to inform the chain of command PRIOR to being absent from drill will result in being marked as an Unauthorized Absence (UA), and may lead to disciplinary action. Per reference (a), all personnel must attend a minimum of 75% of drill periods to maintain satisfactory attendance. Any Cadet or Adult who does not maintain satisfactory drill attendance may be subject to immediate dismissal from the unit at the discretion of the Commanding Officer.
5. Cancelation. This notice remains in effect until 01 January, 2013.
